- Affordability, and
- Acceptability.

Purposes

Staffing guidelines serve several purposes including those that follow:

- To ensure fair and transparent staffing practices across the division;
- To provide a base for annual budget preparations, and
- To offer a mechanism for responding to changes in student enrolments, student needs and programming.

Secretaries

Staffing guidelines are based on the total number of students in the school (not FTE). More time is allocated to high schools (credits, complex timetables, etc.)

The maximum number of hours/day for 1 FTE secretary is 7.50 (CUPE).

Secretaries work 200 days/year. This allows them to work on all non-student days and have three days to use at the principal's discretion.

Educational Assistants

Staffing guidelines are based on several relevant factors including those that follow:

- Student enrolment;
- The number and level of Inclusion and Intervention Plans;
- The number of students requiring speech and language/OT assistance;
- Special program requirements, and
- Pre-Kindergarten requirements.

Itinerant (POD) Educational Assistants are employed for schools in Battleford and North Battleford.

*Please Note: Educational assistants are not tied to particular students. The guidelines help to determine the number of assistants in each school to be deployed as required by the principal or designate. Assignments within the school may change during the year if there is a need to do so.

HR and Student Services personnel meet regularly to review educational assistant levels in all schools.

All requests for additional EA support should be initiated with Student Services. We meet four times a year to review needs and EA staffing.

The addition of Jordan's Principle funding makes sure all First Nations children living within the boundaries of Living Sky School can access the products, services and supports they need, when they need them. This is a separate granting formula with an intensive application process before dollars are made available for staffing and assistance.

<u>Teachers</u>

1. Staffing Guidelines

1.1 Base Staffing

Base staffing is calculated on a curved line that incorporates economies of scale that are realized at larger schools and not realized at smaller schools. As such, there is no longer a simple rate of FTE teachers per student. The table below indicates the number of students required for each increment of FTE teacher at a division-wide PTR of 14.75

*Note that kindergarten staffing is based on half-day programming. (unless noted)

Rationale: Older students are generally more independent and able to work in larger groupings. Having more students in a grade grouping allows for greater economies of scale. There is a minimum number of high school courses that must be run, regardless of the number of high school students.

1.2 High School Programming Factor

There will no longer be a High School Programming Factor for small high schools. This was incorporated into the staffing curve.

Rationale: The curve better approximates the needs of smaller high schools without creating demographically lucky and unlucky schools.

1.3 Small School Factor

There will no longer be a Small School Factor. This was incorporated into the staffing curve.

Rationale: The curve better approximates the needs of smaller schools without creating demographically lucky and unlucky schools.

1.4 <u>Student Services</u>

This allocation should not be used for other purposes.

Part I. (SS – FTE)

Allow 1 FTE teacher to 250 FTE students.

Rationale: All schools require base SST time for students with diverse needs who do not qualify for IIP's.

Part II. (SS – Levels)

Level I:	0.014 teacher / student
Level II:	0.045 teacher / student
Multiple Supports:	0.095 teacher / student

Rationale: SST time is required to create IIP's and facilitate programming for these students.

1.5 Tier 2 Factor – NEW 2018-19 & discontinued for 2020

There will no longer be a Tier Two intervention as of September 2020

1.6 Practical and Applied Arts (PAA)

Manual adjustment up to host school in actual FTE time utilized by visiting students

1.7 Career Guidance (CG)

For schools that have students in grades 10-12, allow 0.002 FTE per student.

1.8 <u>Tier 3 Factor - Continuing practice since 2018</u>

Considers the number of red level students. Based on reading scores. Primarily a Pre- K to 4 intervention.

1.9 Preparation Time (PREP)

Allow 0.11 per FTE teacher.

1.10 Leadership Time

School Community Council:	0.05 FTE
Community Factor:	0.10 FTE

High School Adjustment (Grades 10-12)

If fewer than 50 FTE students, add	0.15 FTE
If between 50 and 99 FTE students, add	0.20 FTE
If between 100 and 199 FTE students, add	0.25 FTE
If more than 200 FTE students, add	0.30 FTE

Allow 0.008 FTE per grade level.

Allow 0.085 per FTE teacher.

Total administrative time will not be less than 0.20 FTE or more than 3.00 FTE.

1.11 Manual Adjustment

This will be applied only in exceptional circumstances in order to meet a unique need. Requests should be made in conjunction with the appropriate superintendent. K-12 schools will be adjusted to have a minimum professional staff of 6.00 FTE.

1.12 LSSD Virtual

Using the experience of our neighboring school division we staffed the Virtual School at 23:1 PTR. This school has administrative leadership, secretary support and limited virtual Student Services and Counselor services. The EAs are assigned by the SSTs of the sending schools and a relationship is cultivated through partnerships by the former public school, the new Virtual school and the professional staff assigned for the success of the student.
