> Public Section: The outstanding amount for the Theodore litigation is \$700,000.00 which necessitates a revised assessment to pay the amount owing. All 15 Public Section boards of education contributing would require a per pupil amount of \$5.50/student to meet current obligations -\$700,000/127,775 = 45.47. 13/15 Public Section boards of education contributing would require a per pupil amount of \$6.00/student -\$700,000/118,336 = \$5.91. 10/15 of boards of education contributing would

require a contribution of \$7.00/student = \$700,000 / 100,574 = \$6.96.
